Case Synopsis

Master Group is one of the most dynamic and diverse business groups of Pakistan. The Group started its operations by first entering in the bedding industry in 1963 with a licensee of Bayer A.G. (Germany) to manufacture foam mattresses in Pakistan and became a pioneer in the market.
